Dr Sylvia Ang is Lècturer in Sociology at Monash University. Her research lies at the intersection of migration studies, ethnic relations, and social inequalities. Her most recent work is interested in how middle-class Asian migrants negotiate privilege and precarity in host countries. She has published in the Journal of Ethnic and Migration Studies, Mobilities, and Ethnic and Racial Studies, among others. She is author of Contesting Chineseness: Nationality, Class, Gender, and New Chinese migrants (Amsterdam University Press).

Paul Denham

Paul Denman is currently the Assistant Secretary in the Immigration Planning and Policy Branch. Paul has responsibility for planning Australia's permanent migration program and policy initiatives supporting the Government's Migration Strategy including the regional migration review and international education policy.

Nik is now the principal solicitor overseeing NSCLC's legal practice in generalist law, tenancy, Older People's Rights Service (OPRS) and our Women's Resource and Engagement Network (WREN). Nik is a nationally accredited mediator.

Dr Hien Nguyen

Hien is a postdoctoral research fellow at the ECU Social Ageing (SAGE) Futures Lab, School of Arts and Humanities, Edith Cowan University. She has 17 years of experience working as a social researcher and development practitioner in Vietnam and Australia. Her scholarship includes migration, ageing, diversity, gender, and development. Her current research questions focus on transnational grandparent migration and social care solutions, with a particular focus on social frailty prevention and reduction among culturally and linguistically diverse (CaLD) communities to promote their health outcomes and wellbeing.

Kedi Kristal

Kedy Kristal (she/her) worked in domestic and family violence from 1983 to 2016 and is currently the Executive Officer for GLBTI Rights in Ageing (GRAI), a non-profit ensuring older LGBTI people are safe and respected. A lesbian activist since 1982 in WA and rural NSW, Kedy co-edited The Laughing Medusa, a bi-monthly lesbian magazine. Her contributions earned her recognition as the 2006 WA Citizen of the Year and the 2007 Western Australian 100 Local Champions. In 2011, she was inducted into the International Women's Day Hall of Fame. Kedy is also a a Director on the board of Tender Funerals WA, a committee member of the Women's Hall of Fame, and serves on various LGBTIQA+ advisory groups.

Lukasz Krzyzowski

Dr Lukasz Krzyzowski is a Vice Chancellor's Research Fellow at Edith Cowan University, working in the ECU Social Ageing (SAGE) Futures Lab. An applied sociologist, his work focuses on the intersections of migration, sexual orientation, and gender diversity. His research addresses complex social challenges faced by marginalised communities, with particular emphasis on LGBTIQA+ individuals, older adults, and culturally and linguistically diverse (CaLD) populations.

Dr Krzyzowski is the founder and lead researcher of The Rainbow Migrants project, which explores the social connectivity and support systems for CaLD LGBTIQA+ individuals (rainbow migrants), including refugees, people seeking asylum, and international students, across their life course. He also serves on the board of GLBTI Rights in Ageing (GRAI) and is a member of the reference group for Western Australia's first whole-of-government LGBTQIA+ strategy, aimed at fostering inclusivity for the LGBTQIA+ community.

Professor Carol Farbotko

Carol Farbotko is a cultural geographer at Griffith Centre for Cultural and Social Research, Griffith University, Queensland. Her research interests include mobility, justice, and climate change. For the last twenty years, she has conducted research in the Pacific Islands, focusing on Indigenous solutions to climate change and mobility challenges. Carol has previously worked for CSIRO.

Dr Zoe Leviston

Zoe's work applies social psychological theory to investigate how individuals, groups, and culture shape people's responses to climate change and other environmental issues. She is especially interested in how group processes and social norms influence people's attitudes and behaviours, and the role of collective action in 'mainstreaming' meaningful climate action. Before commencing with the Australian National University in 2020, Zoe was a Post-Doctoral Research Fellow at Edith Cowan University (2017-2020), and a research scientist at the CSIRO (2004-2017).
